#### The Principal Investigator (PI) will:

1) in advance of submitting the related AUP to the ACC, and using the Scientific Merit Form (SMF) (APP1), provide in writing to the Merit Review Committee (MRC) via the Office of the Vice President (Research) project details, as per the form.

#### The ACC Coordinator will:

- 2) as requested by the PI, facilitate access to the required Scientific Merit Form (SMF) (APP1)
- ensure that scientific merit reviews have been undertaken prior to forwarding Animal Use Protocol (AUP) forms to Animal Care Committee (ACC) reviewers for final ethics review and approval

#### The Merit Review Committee / VPR Office will:

4) identify minimum two reviewers, and forward the PI's SMF and blank Scientific Merit Reviewer Form (SMRF) (APP2) to reviewers requesting form completion and submission within two weeks' time.

### The Scientific Merit Reviewer(s) will:

- 5) within two weeks of Scientific Merit Form receipt, perform the review, and
- 6) submit the review(s) using the Scientific Merit Reviewer Form (SMRF) (APP2) to the Merit Review Committee via the Office of the Vice President (Research)

#### The Merit Review Committee will:

a) provide the PI with written scientific merit reviewer feedback.

- b) If no outstanding questions / concerns have been identified by the reviewer, forward the SMRF forms to the ACC via the ACC Coordinator.
- c) If outstanding questions / concerns have been identified by the reviewer, act as liaison between the PI and Merit Reviewer(s), and append related communications, as appropriate, to the SMRF(s) to be forwarded to the ACC via the ACC Coordinator.

### The ACC Coordinator will:

- 7) forward review results to the ACC and/or its Executive for consideration.
- 8) as applicable, forward any outstanding questions from the ACC to the Merit Review Committee
  - a) continue to act as the liaison between the ACC and the MRC until all outstanding concerns are resolved.
