My Course Description

This course introduces psychological principles that influence physical activity. Student will examine how personality traits, motivation, emotions, and social processes impact performance and participation. Through interactive lectures and real-world examples, students will gain foundational insight into the psychological dynamics influencing physically active lifestyles.

Learning Outcomes

Upon successful completion of this course, you will be able to:

1. **Describe** core concepts and theories in physical activity psychology.
2. **Explain** the relationship between psychological factors and physical activity performance and participation.
3. **Apply** core concepts and theories in assessing athlete and exerciser behaviour.
4. **Analyze** how individual and group differences influence performance and participation.
5. **Evaluate** strategies used to enhance performance and participation.
6. **Reflect critically** on personal attitudes and experiences with physical activity using core concepts and theories.

Notes:

1. Students are expected to complete this assessment by the deadline listed. Should extenuating circumstances arise, students are permitted to submit their assignment up to 72 hours past the deadline without a late penalty. No Academic Consideration is required for this extension. Students completing their assignment beyond the extended deadline will receive a penalty of 1% per hour that it is late (after 24 hours you will receive a zero). Academic Consideration requests may be granted only for extenuating circumstances that began before the deadline and lasted longer than the extension. Students must not provide medical or compassionate documentation to the instructor.
2. This assessment has been designated as being central to the assessment of learning outcomes in this course. Accordingly, students must provide documentation (not to the instructor) for any absence from this evaluation. If you miss this evaluation and have approved Academic Consideration with documentation, you must complete the makeup assessment on Thursday March 4 from 6:30pm to 7:20pm (location to be determined). The makeup assessment is an extension of the Mid-term, and so you will need to present documentation for this assessment, should you need to miss it. Please note that there is only one makeup assessment for the Mid-term. If a student misses the make-up (only with approved considerations), it will be re-weighted to the final which would be worth

70% of your grade, and that this is not ideal. Students approved to miss the makeup will have the weight of this assessment transferred to the Final exam. Students must not provide medical or compassionate documentation to the instructor.

3. You cannot use undocumented absences for Final exams.
