Calendar Course Description (including prerequisites/anti-requisites)

This course is designed to develop an understanding of how Kinesiology can be applied in a professional context to enhance the health, wellness, and functional capacity of clients. Students will learn the fundamentals of clinical kinesiology including program models, clinical skills, privacy/ethics considerations, with the purpose of introducing the practice of Clinical Kinesiology.

Anti-requisite(s): the former Kinesiology 3421A/B.

Prerequisite(s): Registration in the School of Kinesiology.

My Course Description

This course introduces students to the knowledge, skills, and professional judgment required for entry-level practice as a Registered Kinesiologist within Ontario’s regulated health care system. Students will examine the scope of practice defined by the *Kinesiology Act, 2007* and the standards, guidelines, and core competencies established by the College of Kinesiologists of Ontario (COKO). Through an applied, case-based approach, students will develop foundational clinical reasoning skills to assess movement, function, and health status across diverse populations. Emphasis will be placed on selecting, administering, and interpreting assessment tools to inform evidence-based physical activity and exercise interventions. Students will also explore the role of the clinical kinesiologist within interprofessional health teams, considering ethical, legal, and professional responsibilities. By the end of the course, students will be able to connect assessment findings to client-centered intervention design aimed at improving health, functional capacity, and quality of life in real-world practice settings.

Essential Questions

1. What does it mean to practice as a responsible and ethical kinesiologist?
2. How do scope of practice and regulations shape the care we provide?
3. How can movement be used as both an assessment tool and an intervention to improve health and function?

Learning Outcomes

Upon completion of this course, students will be able to:

1. **Explain** the scope of practice, professional standards, and regulatory requirements of Registered Kinesiologists in Ontario **using COKO documents and case examples.**
2. **Apply** COKO standards and ethical principles to **analyze and justify decisions in case-based scenarios.**
3. **Select and administer** basic movement and health-related assessment tools **in simulated or peer-based practice settings following standard protocols.**
4. **Interpret** assessment findings to **identify client needs, risks, and functional limitations in structured case scenarios.**
5. **Design** a basic, evidence-informed exercise intervention **tailored to a client profile, including goals, contraindications, and safety considerations.**
6. **Demonstrate** professional communication and interprofessional awareness **through written or oral case presentations that reflect ethical and client-centered practice.**

Transfer Goals

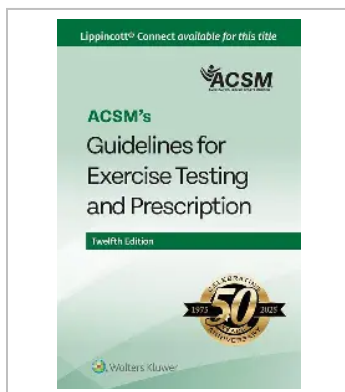
After the course ends, students will independently use their learning to:

1. Practice within the scope, standards, and regulatory expectations of kinesiology in Ontario, making ethical decisions, protecting client privacy, and maintaining professional accountability in diverse practice settings.
2. Assess client needs and apply clinical reasoning to design, implement, and adapt safe, evidence-informed movement and exercise interventions that support health, function, and quality of life.

Notes:

1. This course has **5 online quizzes**, delivered by Brightspace. All quizzes are open book and will be available for completion for 48-hours prior to the submission time of 23:59 EST on the dates noted in the schedule. The 4 quizzes with the highest marks will be counted towards your final grade. Each quiz is worth 5% for a total of 20%. Academic consideration requests will be denied for the first missed quiz. Academic Consideration requests may be granted when students miss more than 1 quiz and these additional missed quizzes will be rescheduled, if possible, or else the assessment value of the additional missed quizzes will be redistributed among the completed quizzes. Additional missed quizzes without academic consideration will receive a score of zero. If all quizzes are missed with approved considerations, the grade for this component will be applied to the final exam.
2. This is a **written assignment**, worth 10% of your final grade, due at 23:59 EST on October 8th. **Write a layperson summary of a COKO policy, practice standard, guideline or core competency.** See sign-up sheet on Brightspace for a list of topics. Students are expected to submit this assignment by the deadline listed. Should extenuating circumstances arise, students are permitted to submit their assignment up to 72 hours past the deadline without a late penalty. No Academic Consideration is required for this extension. Students submitting

their assessment beyond the extended deadline will receive a mark of zero. Academic Consideration requests may be granted only for extenuating circumstances that **began before** the deadline and **lasted longer** than the extension. With approved considerations submission timelines will be decided in consultation with advisors and the instructor. Students must not provide medical or compassionate documentation to the instructor.

3. The **Midterm Exam** will cover all course material up to and including October 9th. This 50-minute exam will consist of multiple-choice and short-answer questions. This is a **designated assessment** considered central to the assessment of learning outcomes in this course. Accordingly, students must provide documentation for any absence from this evaluation. If you miss this evaluation, you must complete the **makeup assessment** which is scheduled for **October 29th 9:30-10:20**. The makeup assessment is an extension of the Midterm Exam, and so you will need to present documentation for this assessment, should you need to miss it. Please note that there is only one makeup assessment for this Midterm. ***The makeup may take an alternative format to the Midterm, e.g., essay style.*** Students approved to miss the makeup will have the weight of this assessment redistributed to the Final Exam. Students must not provide medical or compassionate documentation to the instructor. Students who miss the midterm and makeup without approved academic considerations will receive a grade of zero.
4. The **Final Exam** will cover all course material. This 2-hour exam will consist of multiple-choice and short-answer questions. This assessment is considered central to the assessment of learning outcomes in this course. Accordingly, students must provide documentation for any absence from this evaluation. You cannot use undocumented absences for final exams. If you miss this evaluation, you must complete the makeup assessment. The makeup for the final exam will be held in January. The date, time, and location of this Special Exam will be posted to Brightspace in December.

General information about assessments

- All assignments are due at 23:59 EST unless otherwise specified. Late or missing assignments without academic consideration will receive a zero.
- You are responsible for ensuring that the correct file version is uploaded; incorrect submissions including corrupt files will receive a zero.
- After an assessment is returned, you should wait 24 hours to digest feedback before contacting your evaluator; to ensure a timely response, reach out within 7 days.
- Requests for regrading must include a written explanation and evidence showing how the work meets the assignment criteria or rubric. Requests without clear justification will not be considered.
- Prior to the filing of a written request for relief, you must attempt to resolve the concern regarding a mark or grade through informal consultation with the instructor. If you are dissatisfied with the decision of the instructor or you do not receive a decision from the instructor, a written request for relief must be submitted to the Undergraduate Chair of the School offering this course, within three weeks from the date that the mark was issued.

Rounding of Grades (for example, bumping a 79 to 80%)

This is a practice some students request. The final grade documented is the grade that you have achieved. There is no rounding to the next grade level, or 'giving away' of marks. Please don't ask me to do this for you; the response will be "please review the course outline where this is presented".

INC (Incomplete Standing): If a student has been approved by the Academic Advising Office (in consultation with the instructor/department) to complete term work at a later date, an INC will be assigned. Students with INC will have their course load in subsequent terms reduced to allow them to complete outstanding course work. Students may request permission from Academic Advising to carry a full course load for the term the incomplete course work is scheduled.

SPC (Special examination): If a student has been approved by the Academic Advising Office to write a Special Examination and the final exam is the only outstanding course component, an SPC will be assigned. If the class has a makeup exam, the student is expected to write the makeup exam.
