3. Course Syllabus, Schedule, Delivery Mode

An intermediate level course in organic chemistry designed to complete the core requirements in organic chemistry. The major topics include: concepts of organic synthesis, radical chemistry, the chemistry of beta-dicarbonyls, amines, heterocycles, cycloadditions and pericyclic reactions.

Topics Covered

1. Chapter 19: Aldehydes and ketones

2. Chapter 20: Carboxylic acids and their derivatives
3. Chapter 21: Alpha carbon chemistry: Enols and enolates
4. Chapter 16: Conjugated Pi systems and pericyclic reactions
5. Chapter 22: Amines
6. Chapter 23: Introduction to organometallic compounds
7. Introduction to Heterocyclic chemistry (time permitting)

Contingency plan for an in-person class pivoting to 100% online learning

5. Methods of Evaluation

The final grade for the course will be determined by the following:

Mid-term tests **2 tests at 20% each = 40%.**

Final Exam **40% *cumulative*; 3 hours: Date set by registrar**

In order to pass you need i) a mark 50%, **and** ii) 50% or greater in your laboratory mark **and** iii) a passing grade in the non-laboratory component of the course. The final exam must be written.

Note 1: If a mid-term test is missed for valid reasons, the 20% will be transferred to the final examination. Missing a test for a non-validated reason will result in a grade of zero. There are NO alternate mid-term tests.

Note 2: There are 8 laboratory sessions and 9 reports. In order to pass this course, you must attend at least 6 lab sessions and submit 7 reports. Missed sessions or reports must be for an approved reason (SRA or permission via the Faculty of Science counselling office. Late laboratory reports will be penalized 10% per day or any part thereof.

6. Student Absences

Academic Consideration for Student Absences

Students who experience an extenuating circumstance (illness, injury or other extenuating circumstance) sufficiently significant to temporarily render them unable to meet academic requirements may submit a request for academic consideration through the following routes:

(i) Submitting a Self-Reported Absence (SRA) form provided that the conditions for submission are met. To be eligible for a Self-Reported Absence:

- an absence must be no more than 48 hours
- the assessments must be worth no more than 30% of the student's final grade
- no more than two SRAs may be submitted during the Fall/Winter term

(ii) For medical absences, submitting a Student Medical Certificate (SMC) signed by a licensed medical or mental health practitioner to the Academic Counselling office of their Faculty of Registration.

(iii) Submitting appropriate documentation for non-medical absences to the Academic Counselling office in their Faculty of Registration.

Note that in all cases, students are required to contact their instructors within 24 hours of the end of the period covered, unless otherwise instructed in the course outline.

Students should also note that individual instructors are not permitted to receive documentation directly from a student, whether in support of an application for consideration on medical grounds, or for other reasons. **All documentation required for absences that are not covered by the Self-Reported Absence Policy must be submitted to the Academic Counselling office of a student's Home Faculty.**
