

Earth Sciences 2240G: *Catastrophic Events in Earth's History* Course Outline Winter 2026

1. Course Information

Earth Sciences 2240F considers those events so dramatic and catastrophic that they leave evidence in the geologic record and can threaten life on Earth. Included will be violent volcanic eruptions, mega-earthquakes and the tsunami arising from them, rapid climatic changes and associated storms, and impacts from asteroids and comets. As much as possible, we will use the examples of recent events and processes to help interpret what we read in the rock record.

The content of the course incorporates definitions of basic geologic terminology and concepts required to proceed irrespective of background knowledge.

Course Learning Objectives

The primary goal of this course is to gain an understanding of those (predictable and unpredictable) events that catastrophically punctuate the normal evolution of Earth.

- We will learn what energy sources fuel Earth's processes in rocks, water and atmosphere, and what factors turn ordinary processes into extraordinary ones.
- We will learn the significance of geologic time and we'll learn how to read dates incorporated in ice, sediments, and rocks.
- We will learn to write scientific reports; two assigned topics will be researched and presented in scientific format.

Suggested Weekly Schedule

- This schedule is based upon a 12-week duration; the Winter term is 13 weeks.
- The suggested schedule amounts to understanding **18 to 25 pages per week**.
- You will have to follow this schedule closely for the first half of the term in order to read all of the material that will be tested on the midterm in time.
- There is an extra week at the end of term that will allow you to be flexible in your readings in the second half of the term in order to accommodate the writing of your scientific report. If you follow this schedule exactly you will finish the readings one week before the end of term.

4. Course Materials

Course content was primarily developed by Dr. Neil D. MacRae and updated by Dr. Elizabeth Webb and Dr. Sean Shieh in previous versions of 2240. All course content is mounted on-line; neither texts nor supplemental materials are required.

Note that the instructor owns the IP in the lecture and lecture materials even when such lectures or materials are posted online and students are not to post lectures or lecture materials to any other websites or platforms or use the lecture recording or materials for any other purpose without instructor consent.

Students are responsible for checking the course OWL site (<https://westernu.brightspace.com/>) regularly for news and updates. This is the primary method by which information will be disseminated to all students in the class.

Since this course is delivered online, you'll need a computer with a reliable internet connection.

5. Methods of Evaluation

Grading Scheme and Assessment Dates

- 20% Mid-Term Examination
- 25% non-cumulative End-of-Term Examination
- 40% Scientific Report (2 assignment parts due Oct. 7 and Dec. 2 [course essay requirement])
- 15% nine Quizzes on course content

20% Mid-Term 2 hour written examination, online

The Mid-Term Examination covers the first half of the course: Unit 1 and Unit 2 inclusive (to end of Chapter 9). Typically, ~30 multiple choice questions, ~10 fill-in-the-blank questions and ~5 short answer questions.

Tentative Date and Time: Tuesday February 24, 6:00-8:00 pm.

For online examinations, students are not permitted access to any additional materials including electronic devices.

The instructor must receive an academic consideration notification (either with or without supporting documentation) within 48 hours of the scheduled mid-term examination for the student to be permitted and scheduled to take the make-up mid-term exam. This is the mechanism to identify those students that need to write the make-up mid-term exam. See section 6 about submitting an academic consideration request.

Make-up Mid-Term Examination [online] will occur on Saturday, February 28, 3:00-5:00 pm.

Students that miss writing the make-up mid-term exam **must** submit an academic consideration request with supporting documentation within 48 hours of the scheduled make-up mid-term exam. The instructor has designated the make-up mid-term exam as the one assessment in this course that requires academic consideration with supporting documentation (again, see section 6).

Students that miss writing both the mid-term and the make-up mid-term (with supporting documentation) will write the mid-term the next time the course is offered (usually the next term).

25% End-of-Term 2 hour written examination, online

The End-of-Term examination is non-cumulative, covers the second half of the course: Unit 3 & Unit 4 inclusive (from Unit 3 Introduction to end of Chapter 20). Similar format as the mid-term exam.

Date and time to be determined by the Registrar's office

For online examinations, students are not permitted access to any additional materials including electronic devices.

Make-up End-of-Term Exam [online]: To be announced, determined by Registrar's office

You can only take the make-up End-of-Term (“special”) Exam with permission from an academic counsellor. If you miss the End-of-Term Exam, please contact the Academic Counselling office of your Faculty of Registration as soon as you are able to do so. They will assess your eligibility to write the Special Examination (the name given by the University to a makeup Final Exam). See the Academic Calendar for details (under [Special Examinations](#)), especially for those who miss multiple final exams within one examination period.

If a student fails to write a scheduled **Special Examination**, the date of the next Special Examination (if granted) normally will be the scheduled date for the final exam the next time this course is offered. The maximum course load for that term will be reduced by the credit of the course(s) for which the final examination has been deferred.

You may be eligible to write the Make-up End-of-Term Exam if you are in a “**Multiple Exam Situation**” (e.g., more than 2 exams in 23-hour period, more than 3 exams in a 47-hour period. Students who have any of these types of conflicts and who wish to explore alternative scheduling options should submit an exam conflict through the [Student Absence Portal](#).

40% Scientific Report (Assigned Research Topic) submitted in 2 parts:

- 10% Draft of Introduction and Reference List: **Due Friday February 13**
- 30% Final Report (2500 words) **Due Friday March 28**

The assigned research topic and further detailed assignment information and instructions will be provided on the OWL course site.

This is an essay course, a passing grade on assignment 2's final scientific report (the 30%) is required to pass the course (see section 6). In other words, students must submit a final scientific report (not optional).

About Submission and Due Dates of Scientific Reports

- Reports are submitted as OWL “Assignments”. It is best to upload your assignment reports in **two formats**: a MS Word document (to generate the Turnitin result) and a PDF (to preserve your report’s formatting).
- When you submit an assignment, you will receive an email receipt from OWL and an email receipt from Turnitin.com. **Keep these for your records.** Turnitin.com is the software that Western uses to check submitted work for plagiarism. This software compares your report to everything that has been published, everything on the internet, and all other student papers that have been previously submitted to Turnitin (from any university).
 - **Please Note:** It can take several minutes, several hours or even a day for Turnitin to generate a report and you will not be allowed to resubmit an assignment while Turnitin is generating the report. **Hence, you should not submit an unfinished draft close to the deadline in case your Turnitin result is delayed and you are not able to submit your final version before the deadline.**
 - Extensions will not be granted because *you* have a time problem on the Due Date; it’s up to *you* to manage your time and get the report assignments submitted. Students should not submit an academic consideration request without documentation as it will be **denied**.
 - If you require an extension for a legitimate medical or personal reason (e.g. physical illness or extreme stress), please get documentation from your doctor and take it to an academic counsellor in your home faculty to submit an academic consideration request with documentation.

15% Graded Quizzes (at intervals during the course; see *Weekly Schedule*)

Quizzes 1-4 **must** be completed by Friday February 13. **Don’t leave them until the last minute!** Similarly, quizzes 5-9 **must** be completed by Thursday April 9. Again, do not wait until the last minute. The lowest quiz score will be dropped. There will be **no extensions**.

Graded quizzes may be attempted/submitted **at any time** before the due date. It makes sense to do them as you go, at the end of each chapter or section to which they apply. The quiz settings are set to **one attempt only** with unlimited time; Once submitted, the grade and incorrect questions (without answers) will be displayed/provided to you.

A three-day grace period is provided to students to complete all quizzes without penalty by the due dates.

If you require an extension for a legitimate medical or personal reason (e.g. physical illness or extreme stress), please get documentation from your doctor and take it to an academic counsellor in your home faculty to submit an academic consideration request with documentation.

Evaluation Scheme for Missed Assessments

If you miss the midterm and have been granted Academic Consideration to take the makeup, it will be at a date and time scheduled by the Registrar's Office.

When a student misses the Final Exam and their Academic Consideration has been granted, they will be allowed to write the Special Examination (the name given by the University to a makeup Final Exam). See the Academic Calendar for details (under [Special Examinations](#)), especially for those who miss multiple final exams within one examination period.

This is an essay course, so failing to submit your essay is simply not an option. Students are expected to submit the final essay by March 28 (earlier submissions are encouraged!). Should extenuating circumstances arise, students **do not** need to request Academic Consideration and are permitted to submit their assignment up to 72 hours past the deadline without a late penalty.

If a student submits their assessment beyond 72 hours (3 days) past the deadline, a **late penalty** of 10% per day will be applied. Reports submitted 5 days after the no-penalty period will not be accepted (see Essential Learning Requirements below). Academic Consideration requests may be granted only for extenuating circumstances that started before the deadline and last longer than the No-Late-Penalty Period. Please note that it is University policy that all course work must be submitted by the last day of classes (April 9).

Essential Learning Requirements

Even when Academic Considerations are granted for missed coursework, the following are deemed **essential** to earn a passing grade in the course:

- a passing grade on the final essay as this course is designated as an “essay course”
- 50% on the final exam (or Special Exam, with Academic Consideration)

IF YOU DO NOT MEET BOTH OF THESE REQUIREMENTS, YOU WILL NOT PASS THE COURSE.

In the rare cases where students are unable to submit their final essay or take the final exam or Special Exam but they are granted Academic Considerations, the student may receive a grade of Incomplete (INC) and complete their requirements the next time the course is offered (at which time a different instructor may be teaching the course). However, their maximum course load may be reduced during the term in which they complete their course requirements.

6. Additional Statements

6.1 Missed Coursework / Student Absences

Students who experience an extenuating circumstance sufficiently significant to temporarily render them unable to meet academic requirements (e.g., illness, injury) may submit a request for academic consideration.

Students must familiarize themselves with the *University Policy on Academic Consideration – Undergraduate Students in First Entry Programs*, posted on the Academic Calendar:

This policy does not apply to requests for Academic Consideration submitted for **attempted or completed work**, whether online or in person. All requests for Academic Consideration **must be made within 48 hours** after the assessment date or submission deadline.

All Academic Consideration requests must include supporting documentation; however, recognizing that formal documentation may not be available in some extenuating circumstances, the policy allows students to make one Academic Consideration request **without supporting documentation** in this course. However, the following assessments are excluded from this, and therefore always require formal supporting documentation:

- **Mid-Term Examination** (Designated by the instructor as the one assessment that always requires documentation when requesting Academic Consideration)
- **Examinations scheduled during official examination periods** (Defined by policy)

When a student *mistakenly* submits their one allowed Academic Consideration request **without supporting documentation** for the assessments listed above, the request cannot be recalled and reapplied. This privilege is forfeited.

6.2 Essential Learning Requirements

Even when Academic Considerations are granted for missed coursework, the following are deemed essential to earn a passing grade.

- a passing grade on essays or lab reports (i.e., assignment #2's full scientific report) in a course designated as an “essay course” (i.e., with a suffix of E, F, G, or Z) to satisfy the Senate requirement that students must demonstrate “some minimal competence in essay writing” in order to pass the course.

The consequence of not meeting the above requirement (a grade of 49 or lower on assignment 2's full scientific report) is the student would not pass (would fail) the course.

6.3 Use of Generative AI Tools

The use of generative AI tools (e.g., ChatGPT, Microsoft Copilot, Google Gemini, or similar platforms) is **not permitted** in the completion of any course assessments, including but not limited to: assignments, scientific reports, quizzes, and final examinations.

Using such tools for content generation, report writing, problem solving, translation, or summarization—when not explicitly allowed—will be treated as a **scholastic offence**.

If the use of generative AI is permitted for a particular assessment, the conditions of use will be specified by the instructor in advance. If no such permission is granted, students must assume that use is prohibited. It is your responsibility to seek clarification before using any AI tools in academic work.

6.4 Religious Accommodation

When conflicts arise with a religious holiday that requires an absence from the University or prohibits certain activities, students should request an accommodation for their absence in writing to the course instructor and/or the Academic Advising office of their Faculty of Registration. This notice should be made as early as possible, but not later than two weeks prior to the writing of the examination (or one week prior to the writing of the test).
