English 3353F (001) The Woman Question: Nineteenth-Century Women Writers Fall 2025

Instructor: Dr. Jo Devereux

Prerequisites: At least 60% in 1.0 of English 1020-1999 or permission of the Department. Unless you have either the requisites for this course or written special permission from your Dean to enroll in it, you may be removed from this course and it will be deleted from your record. This decision may not be appealed. You will receive no adjustment to your fees in the event that you are dropped from a course for failing to have the necessary prerequisites.

Course Description

In the nineteenth century, women readers and women writers were an important part of the new mass market for English literature, often leading in the emergent campaign for women's rights. This course will discuss these and other issues in fiction, non-fiction, and poetry by women from the 1790s to 1900. 3 hours, 0.5 course

Objectives:

By the end of the course, successful students will be able to:

- demonstrate increased proficiency in research about nineteenth-century British literature
- present their analysis of nineteenth-century writings by and about women in a clear, compelling, and concise prose style free from technical errors

Academic Consideration
