DRAMA TO THE RESTORATION

In order to develop a wide-ranging competency to teach and research in the field of Drama to the Restoration, candidates will prepare a reading list according to the instructions and requirements below.

INSTRUCTIONS

1. Field Exam

- i. Students must read all of the titles on the CORE reading list.
- ii. In addition to the CORE reading list, students are required to add ONE-THIRD as many plays extant in the period.

2. Exam Structure

- i. Students are required to answer THREE questions in all. All questions are of equal value.
- ii. Students must not discuss the same play more than once.
- iii. In the course of the examination as a whole, students should discuss a play or plays from early in the period and late in the period.
- iv. Students may answer ONE of the questions on Shakespeare only, by drawing examples from three or more of his plays.
- v. In each answer (apart from an answer on Shakespeare, should you take up this option) discuss plays by no fewer than THREE dramatists. Shakespeare may be one of the dramatists discussed in each of your answers.
- vi. Students' answers should demonstrate a comprehensive knowledge of both Shakespearean and non-Shakespearean drama, and an ability to deal with diverse topics and critical interests.
