# **Calendar Course Description:**

An introduction to the basic aspects of reading, interpreting, evaluating, and presenting research to better understand the research process in physical activity. Measurement and data collection techniques from physical and social science areas of kinesiology will be examined using both quantitative and qualitative research designs employed in movement science.

Antirequisite(s): Foods and Nutrition 2032A/B, Health Sciences 2800, Health Sciences 2801A/B, Psychology 2801F/G, Psychology 2802F/G, Psychology 2830A/B, Psychology 2840F/G, the former Psychology 2800E, the former Psychology 2820E.

- 1. This assessment has been designated as being central to the evaluation of learning outcomes in this course.
