Calendar Course Description (including prerequisites/anti-requisites):

The central purpose of this course is to examine the psychological bases of exercise and physical activity. Emphasis is placed on understanding the motives and barriers underlying involvement in exercise and physical activity, the psychological benefits derived from acute and chronic involvement, the situational and personal determinants associated with failure to initiate and/or adhere to exercise and physical activity programs, the theoretical perspectives advanced to account for involvement, and intervention strategies used to stimulate and/or maintain involvement in exercise and physical activity.

Notes:

- Students are expected to submit each of the <u>psychological surveys</u> on the date listed. Should extenuating circumstances arise, students are permitted to submit their psychological survey up to 72 hours past the deadline without a late penalty. No Academic Consideration is required for this extension. As Students submitting a survey beyond the extended deadline will receive a penalty of <u>1% per day</u> that it is late (note that each psychological survey is only worth 2%, and thus would receive a **zero** if submitting two days past the 72 hour grace period). Academic Consideration requests may be granted only for extenuating circumstances that <u>began before</u> the deadline and <u>lasted longer</u> than the extension. Students must not provide medical or compassionate documentation to the instructor. The 72 hour no late penalty does not apply to the tutorial reflections.
- 2. Designated Assessment: This assessment has been designated as being central to the evaluation of learning outcomes in this course. Accordingly, students must provide documentation for any absence from this evaluation. If you miss this evaluation, you must complete the makeup assessment as follows: An independent research project, with a final due date being decided on a case-by-case basis. The makeup assessment is an extension of the Group Research Project, and as a passing grade is required given this is an essay designated course, cannot be missed or re-weighted. Please note that there is only one makeup assessment for this Group Research Project. Students must not provide medical or compassionate documentation to the instructor. As this is a group project, the other group members of the individual who submits a documented absence also need to reach out to the Instructor as soon as possible for instructions on how to proceed with the final submission.
- 3. You cannot use undocumented absences for final exams.

General information about assessments

- All assignments are due at 23:59 EST unless otherwise specified
- Students are responsible for ensuring that the correct file version is uploaded; incorrect submissions including corrupt files could be subject to late penalties (see below) or a 0
- ☑ Written assignments will be submitted to Turnitin (statement in policies below)
- Students will have access to Turnitin reports before their submission is graded. Students may have 1 submission to Turnitin.
- A student might not receive the same grade as their group members if it is determined that the distribution of work was not equal
- After an assessment is returned, students should wait 24 hours to digest feedback before contacting their evaluator; to ensure a timely response, reach out within 7 days
- Prior to the filing of a written request for relief, students must attempt to resolve the concern regarding a mark or grade through informal consultation with the instructor. If the student is dissatisfied with the decision of the instructor or does not receive a decision from the instructor, a written request for relief must be submitted to the Undergraduate Chair of the School offering this course, within three (3) weeks from the date that the mark was issued.

Rounding of Grades (for example, bumping a 79 to 80%)

This is a practice some students request. The final grade documented is the grade that you have achieved. There is no rounding to the next grade level, or 'giving away' of marks. <u>Please don't ask me to do this for you; the response will be "please review the course outline where this is presented"</u>.

Information about late or missed assessments:

- Late assessments without academic consideration (excluding the psychological surveys) will be subject to a late penalty of 5% per day
- One make up test opportunity will be offered for students who miss the midterm exam and have a documented absence approved. For students who miss the midterm exam without an approved documented absence the 20% is reweighted to the final exam.

Course-specific conditions:

To pass the course, students must not miss 40% or more of the assessments prior to the final exam. Therefore, if a student misses both the midterm (worth 20%) and all the Participation Activities (worth 20%) – even with academic consideration, the student will not have adequately met course objectives and therefore will receive an F in the course. Further, to meet the essay component of the course, students must complete and receive at least 50% on the group research paper (worth 25%) or all other assessments (worth 40%) to pass the essay requirement for this course. Students who do not receive a 50% on the group research paper will be debarred from the final exam and will receive an F in the course.

INC (Incomplete Standing): If a student has been approved by the Academic Advising Office (in consultation with the instructor/department) to complete term work at a later date, an INC will be assigned. Students with INC will have their course load in subsequent terms reduced to allow them to complete outstanding course work. Students may request permission from Academic Advising to carry a full course load for the term the incomplete course work is scheduled.

SPC (Special examination): If a student has been approved by the Academic Advising Office to write a Special Examination and the final exam is the only outstanding course component, an SPC will be assigned. If the class has a makeup exam, the student is expected to write the makeup exam. If the class doesn't have a makeup exam or the student misses the makeup exam for reasons approved by the Academic Advising Office, the student will write the exam the next time the course is offered. Outstanding SPCs will reduce the course load for the term the exam is deferred as outlined in Types of Examinations policy

Absence from Course Commitments

Students must familiarize themselves with the Policy on <u>Academic Consideration – Undergraduate Students in First Entry Programs</u>

Examples of flexibility in assessment include when there are assessments not required for calculation of the final grade (e.g. 8 out of 10 quizzes), when there is flexibility in the submission timeframe (e.g. 72 hour no late penalty period), or when timed assessments (e.g., quizzes) are available over an extended period of time (e.g., when you are given a 72 hour time period to start – and finish – the assessment).

Please note that academic considerations in this course are granted by the academic advisors in your home unit and implemented by the instructor of this course in accordance with information presented in this course syllabus. Supporting documentation for academic considerations for absences due to illness should use the Student Medical Certificate or, where that is not possible, equivalent documentation by a health care practitioner.
