This course will focus on (a) intervention grounded in behaviour change theory that positively influences physical activity in disease populations and (b) using exercise as a therapy to improve various health outcomes.

My Course Description

This course focuses on designing and evaluating inclusive physical activity and other health behaviour (e.g., sleep, diet) interventions grounded in behaviour change theory that promote health and well-being among healthy populations (e.g., children and youth, adults, older adults) as well as those living with chronic conditions (e.g., anxiety and depression, type 2 diabetes). Emphasis is placed on translating theory into practice so students can apply learnings in clinical and non-clinical contexts later in their careers as “health coaches”. Through interactive lectures and practical assignments students will develop “health coaching” skills to create tailored, evidence-based physical activity programs that promote long-term health and well-being.

Learning Outcomes

Upon successful completion of this course, you will be able to:

- 1) **Describe** key behaviour change theories and their relevance to promoting physical activity and other health behaviours.
- 2) **Explain** how individual, social, and environmental factors influence physical activity and other health behaviours across diverse populations.
- 3) **Apply** behaviour change theories to design tailored physical activity and other health behaviour interventions for healthy individuals and those with chronic conditions.
- 4) **Analyze** the components and delivery methods of existing physical activity and other health behaviour interventions.
- 5) **Evaluate** the effectiveness physical activity and other health behaviour programs using appropriate assessment tools.
- 6) **Reflect critically** on the challenges and ethical considerations involved in implementing physical activity and other health behaviour interventions across various populations.

1. This course has 10 in-class participation quizzes (1 question worth 1 mark each). The 5 quizzes with the highest marks will be counted towards your final grade. Academic Consideration requests will be denied for any missed/incorrect quizzes.
2. Students are expected to submit this assignment by the deadline listed. Appealing a Grade Within this Course
