Calendar Course Description (including prerequisites/anti-requisites):

This course will examine the relationship between exercise and cognitive neuroscience. Students will be provided with an overview of fundamental methodologies used in cognitive neuroscience research before examining the literature on exercise neuroscience, with a focus on different study designs and application to various age groups and clinical populations.

My Course Description

Welcome! This course is intended to provide you with an overview of the field of exercise neuroscience. We will begin with an overview of the fundamental methodologies used in neuroscience (e.g., EEG, MRI) before examining the literature – from classic studies to the newest cutting-edge findings – in this exciting field. In this course, you will have the opportunity to refine your critical thinking and interpretation skills. Throughout the course you are expected to participate in meaningful, engaging discussions.

Notes:

1. Students will attend two seminar “group discussion” dates throughout the semester. Participation in each will be worth 10% of the final mark. For missed group discussions with approved accommodations, marks will be transferred to the final assignment. For missed group discussions without approved accommodations, students will receive a 0. If a student arrives late for their assigned discussion session they will receive a 0 (or at the discretion of the Instructor).
2. In-class assignments will require advance preparation with a written response to be completed and submitted during class time. If one in-class assignment is missed with approved accommodations, the mark will be transferred to the other in-class assignment (i.e., if In-class assignment #1 is missed, In-class assignment #2 will be worth 30%). If both in-class assignments are missed with approved accommodations, the marks will be transferred to the final assignment. In-class assignments missed without approved accommodations will receive a 0.
3. Students will be put into groups of 4-6 students and present on a pre-selected article to the class. Marks will be a combination of group-based and individual-based (from peer assessments). If a student misses the presentation with approved accommodation, the mark will be transferred to the final assignment. If the group presentation is missed without approved accommodation, the student will receive a 0.
4. The final assignment is a written grant proposal. Details will be provided in class. As this is a final assessment, undocumented absences **cannot** be applied. Approved accommodations will be treated on a case-by-case basis (e.g., extended deadline). A late penalty of 20% per day will apply.

Rounding of Grades (for example, bumping a 79 to 80%)

This is a practice some students request. The final grade documented is the grade that you have achieved. There is no rounding to the next grade level, or 'giving away' of marks. Please don't ask me to do this for you; the response will be "please review the course outline where this is presented".

Appealing a Grade Within this Course
