#### 4. Business arising from previous meeting

### 4.1 Campus Updates

- Health Safety and Well-Being provided an update to the committee regarding the modules in use and in development for WorkSafe@Western.
- Committee discussed maintaining continuity with currently used practices for chemical inventories, inspections and management of inspection actions. As campus community starts to use the new platform more frequently support will be needed to assist users.
- Rollout of inspection modules has gone well. Campus members are being educated on how to manage requested actions.

#### 5. Review and Assess Trends

#### 5.1 Accident/Injury Report

- As of the end of May 2023, 170 incidents have been reported on campus: 97
  First Aid related incidents, 29 Lost Time related incidents, 34 Health Care related incidents and 10 Near miss/Hazard reports.
- In May 2023, Facilities Management accounted for 32% reports, Animal Care for 13% of reports, Western Libraries 10%, with the balance of the reports came from 12 other units on campus.
- When compared to historical data from 2021 and 2022, May incidents were slightly higher. This could be attributed to an increased return to work on campus.

### 5.2 Critical injuries

• An incident on June 6<sup>th</sup> 2023 resulted in a fracture of an arm. MOL visited the site and there were no orders for campus as a result of the investigation

### **5.3** Workplace Inspections

Data from May 9<sup>th</sup> 2023 – June 27<sup>th</sup>.

- 12 inspection dates completed in 24 business.
- 163 items found for corrective action by units inspected.
- Reportable Items.
  - o 57 orders are open for actions
  - o 11 items past due
- Health Safety and Well-Being commented the number of actions for resolution have increased relative to the previous system due to the system's ability to do direct assignment of a location related to the issue identified. In the long term this will be a better method to manage compliance with regulations
