4.1 Campus Updates

- Continue to monitor waste water on campus. Very low levels of COVID markers across campus.
- Although masking is no longer required, we continue to encourage masking on campus.
- Hand sanitizers, masks and test kits continue to be available on campus.
- Geese management.
 - Initiatives have been started in educating the community on geese, their nesting habits, their consequences on traffic.
 - An online geese reporting tool has been created by FM to allow for reporting on geese issues.

5. Review and Assess Trends

5.1 Accident/Injury Report

- As of the end of February 2023, 61 incidents have been reported on campus: 42
 First Aid related incidents, 10 Lost Time related incidents and 9 Health Care
 related incidents.
 - Of these 61 incidents, falls were the primary contributor to First Aid and Lost Time cases (13 and 5 cases respectively). Over Exertions/Strains were the primary contributor to Health Care cases (7 cases).
- In February 2023 alone, 32 incidents were reported; 21 of which were First Aid related, 5 Health Care related and 6 Lost Time related.
 - More than 80% of these incidents were caused by a fall, over exertion/strain or being struck against.
- In February 2023, Food Services accounted for 38% of cases, while FM accounted for 19% and Animal Care for 13%.
- When compared to historical data from 2021 and 2022, we have had a higher amount of incidents per month in 2023. This could be attributed to an increased

return to work on campus.

5.2 Critical injuries

- One critical injury was reported on February 28th 2023.
 - A worker sustained a critical injury after slipping on ice near the Health Sciences Building.
 - The accident location was inspected by the Ministry of Labor, and actions have been taken to prevent further accidents.
 - FM immediately salted and cleared the space of snow and ice.

5.3 Workplace Inspections

- Data from February 14th March 23rd 2023.
- 8 inspection dates completed in 8 buildings.
- 77 items found for corrective action by units inspected.
- 22 items were corrected during inspection.
- The 4 leading causes for corrective action were chemical labeling, eye wash/shower safety station, electrical hazards and chemical storage.
- Reportable Items.
 - o 18 orders outstanding.
 - o 1 order past due.
