# **DESCRIPTION**

This course will provide a detailed investigation of the context, arguments, significance, and influence of Kant's most famous text in ethics, the *Groundwork for the Metaphysics of Morals*.

## **OBJECTIVES**

Students completing this course successfully will (1) be intimately familiar with one of the most important texts in the history of ethics, (2) have demonstrated an ability to comprehend complex philosophical arguments and reflect critically upon them, and (3) be able to write concise argumentative papers exhibiting research competence.

# **ACCOMMODATION**

## **EVALUATION OF ACADEMIC PERFORMANCE**

At least three days prior to the deadline for withdrawal from a course without academic penalty, students will receive assessment of work accounting for at least 15% of their final grade.
