# PHIL3340 Philosophy of Biology for Biologists

#### **DESCRIPTION**

An introduction to philosophical methods including reading and writing philosophical arguments, followed by four topical modules. These four modules focus on particular fields within the life sciences: evolutionary biology, genetics and genomics, ecology, and cognitive science. Throughout these modules students will examine cases that highlight various types of philosophical issues related to research in the life sciences, such as: What is life? Is there a fundamental unit of selection? Do moral norms evolve? What are the ethical concerns related to gene editing technology? Is there a balance of nature? To what extend our behaviors and psychology constrained by our biology? An important portion of the course will be discussion-based. A constructive and respectful participation is key for guaranteeing the best experience for everyone in the course.

#### **OBJECTIVES**

- Survey some contemporary philosophical debates in the life sciences and explore their historical and social significance.
- Develop analytical and communication skills in philosophy and learn how to apply them
  to issues arising in the life sciences. This includes using critical thinking methods to
  identify, interpret, and communicate ideas and arguments, both in writing and in the
  context of group discussions.
- Develop advanced skills in structuring and leading group discussions.

### **EVALUATION OF ACADEMIC PERFORMANCE**

At least three days prior to the deadline for withdrawal from a course without academic penalty, students will receive assessment of work accounting for at least 15% of their final grade.
