#### **DESCRIPTION**

A close reading of the text of Aristotle's *Nicomachean Ethics* with a focus on the human good, the 'Function Argument', character virtues, friendship, pleasure, practical wisdom, and the nature of happiness.

Both are accessible introductions to the main topics in the *Ethics* and will help students worth through the text.

#### **OBJECTIVES**

This course has two objectives. The first is to give students of philosophy an introduction to the origins and foundations of their discipline, including the problems that define it. The second is to

help students develop their ability to read and understand difficult philosophical texts and to reflect on the ideas and arguments they offer us. These are basic skills that every well-rounded philosopher should have.

## **EVALUATION OF ACADEMIC PERFORMANCE**

At least three days prior to the deadline for withdrawal from a course without academic penalty, students will receive assessment of work accounting for at least 15% of their final grade.
