Description

A survey of a number of core questions and issues in the philosophy of law, some arising in particular areas of law (property, contract, tort, criminal and constitutional) and others raised about law in general (for example, what is the relationship between law and morality?).

Objectives

This course has two main objectives. The first is to introduce students to the philosophy of law. The second is to help them develop the skills philosophy requires: careful reading, critical thinking, and clear writing.

Texts

All readings will be available online, on the course OWL page.

Requirements and evaluation

1) Two short papers (five double-spaced pages): $30\% \times 2 = 60\%$. There will be four topics for you to choose from, each with its own due date. You may write any two you choose. You may also write a third paper and, if you choose, a fourth, in which case your best two grades will count toward your final grade. I will post a document with the topics and due dates on the course OWL page by the first day of classes.

2) A final exam: 40%

Late papers

Late paper will be subject to a penalty of 2%/day, to a maximum of 10%. I will accept papers after they have accumulated the full penalty, until the last day of the classes, Dec. 8, 2021.

If you need an extension on a paper, you will need to see an academic counsellor in the office of the dean of your faculty. Your counsellor will get in touch with me with any recommendations they have. I am not permitted to accept any documentation, medical or otherwise; please submit

Evaluation of academic performance

At least three days prior to the deadline for withdrawal from a course without academic penalty, students will receive an assessment of work accounting for at least 15% of their final grade. For 3000- or 4000-level courses in which such a graded assessment is impracticable, the instructor(s) must obtain an exemption from this policy from the Dean and this exemption must be noted on the corresponding course syllabus. In rare instances and at the Dean's discretion, other courses could receive a similar exemption, which also must be noted in the course syllabus.

Course assignments: final deadlines

The last day of scheduled classes in any course will be the last day on which course assignments will be accepted for credit in a course. Instructors will be required to return assignments to students as promptly as possible with reasonable explanations of the instructor's assessment of the assignment.
