**DESCRIPTION**

An introduction to recent debates on metaphysical questions. This year’s focal topic will be propositions, which connects closely with: what kinds of things there are (mental, physical, abstract, non-countables); the “being of non-being”; the nature of unity; linguistic and mental meanings; Idealism; facts, truth and Relativism; and modality. We will approach the topic of propositions through the lens of three key figures in Analytic metaphysics: Frege, Russell and Kripke.

**OBJECTIVES**

The twin objectives are honing of philosophical skills and enriching students’ familiarity with some “touchstone” material in 20<sup>th</sup> Century Metaphysics in the Analytic tradition. In terms of skills, the emphasis will be on: advanced philosophical writing; close reading of notoriously challenging texts; methodological reflection; and respectful but incisive philosophical dialogue.

**METHOD OF EVALUATION**

Group Debate: 5%

In-Class Test: 15%

Five “Briefing Notes”: 40%

- On the day they are discussed in class, students will submit 2-3 page (i.e., 750-1000 words) “reader responses” to selected writings, consisting of an outline of the central *argument*. (This is to be sharply contrasted with an outline of the *paper*, section-by-section.)

- Each Briefing Note is worth 10%, and all are obligatory. However, the lowest grade will be dropped
