# PHILOSOP 2661F-001 Philosophy of Religion

#### **DESCRIPTION**

This course examines philosophical issues particular to religion. Issues that will be discussed include: the nature of God, whether God exists, the problem of evil, the relation between reason and religious beliefs and practices, the relation between religion and morality, how ethnic and gender differences should influence our religious thinking, and whether religion is a natural phenomenon.

- 2. Learn historical arguments for God's existence and characteristics.
- 3. Consider religion as a natural phenomenon.
- 4. Investigate the relation between religion and reason.
- 5. Investigate the relation between religion and morality.
- 6. Consider how ethnic and gender differences influence religious thinking.
