#### **COURSE DESCRIPTION**

Advances in neurotechnology over the past two decades have injected new life into old debates about the nature of consciousness, personhood, the self, personal identity, free will, autonomy, privacy, moral responsibility, and neurotypicality. Neuroscientists can now use neurotechnology to communicate with persons in chronic vegetative states, augment the brain's natural capabilities, implant and erase memories, restore functions in persons with severe brain damage, ameliorate the symptoms of some mental illnesses, and even create miniature human brains that may or may not have qualitative experiences. The aim of this course is to engage in lively debates around each of these developments. The course should be of interest to students majoring in philosophy of mind, philosophy of science, ethics, psychology, cognitive science and/or neuroscience.

#### **TEXTS**

A combination of philosophical, scientific, and popular press articles extracted from philosophical and scientific journals, books, textbooks, and anthologies will be made available to students as PDF files on OWL.

## **OBJECTIVES**

Students who successfully complete this course will have developed a detailed understanding of some of the major philosophical issues that emerge around recent advances in neurotechnology. They also will have learned how to critically evaluate seminal philosophical works that engage with these issues, as well as how to formulate and defend an argument on a topic in this research area that interests them.

## **METHODS OF EVALUATION**
