COURSE DESCRIPTION

This course is an introduction to the philosophy of mind. It covers a broad range of traditional questions in this field, such as:

- What is a mind or a mental state?
- Can mental states be explained in the same way as other things (such as the motion of physical bodies)?
- Do we really know what others feel or experience?
- What is the relationship between sensory experience and thought?
- What is a person and under what conditions does a person continue to exist?
- Does the determinism of physics imply that we have no free will?

Please note that this is a fully online, asynchronous course based on short online videos. Access to the Internet on a weekly basis is required.

LEARNING OUTCOMES

By the end of this course, you should be able to explain and evaluate the main philosophical arguments and positions discussed in this course both orally and in writing. You should acquire and/or improve upon general skills useful for critically engaging with philosophical ideas as well as other pursuits, including analyzing, and critically evaluating arguments, skills involved in

effective oral and written communication, and fruitful engagement with peers.

STATEMENT ON THE USE OF GENERATIVE ARTIFICIAL INTELLIGENCE (AI)

In this course, <u>the use of generative AI (including automatic translation tools, grammar checkers, text-generating AI assistants such as ChatGPT, Claude, and similar) is prohibited.</u>

METHOD OF EVALUATION

The primary method of evaluation for this course is a series of essays of maximum 850 words each. Each essay addresses a relatively narrow question about the course material. In total, you will have **four opportunities** to write essays. **Your course grade will be the average of your three best essays**.

Example

You have written four essays, for which you have obtained the following grades: 80%, 50%, 90%, 80%. We discard the 50% essay. The average of the remaining three is 83.3%. This would be your course grade before rounding.

In principle, you can have a grade of 100% by writing only three essays, but we recommend writing all four. Many students who have little practice writing essays find that they need some practice before their results correspond to their grade expectations.

The essay due dates will be spaced roughly equally throughout the term.

Anti-AI measures for essays (important!):

- In this course, you are required to show the process by which you developed your essay. Showing an adequate process is an integral part of the grading rubric, and you will lose points for failing to show an adequate researching and writing process. You must make accessible:
 - Your notes
 - Your outline or any similar sketch
 - o All drafts
- To this end, all essay work, from notetaking to drafting and final copy editing, **must take place entirely within a single Google Docs document**, which is to be shared with edit privileges with the designated course Google Account. This allows your instructor and graders to see your entire work process through the revision history.
- Essays submitted without an edit history showing your work from notetaking and outlining to drafting will be given a grade of zero. Such history is considered an integral part of your required submission.
- Furthermore, when writing essays, you are required to cite all relevant parts of the course presentations or textbook with precise page numbers. Essays that fail to satisfy this

requirement will incur a penalty of up to 20%.

• If your submitted document leaves some doubt regarding the method used to prepare the essay, we will invite you to discuss it in person or on zoom.

This course implements flexible deadlines in lieu of minor academic considerations. By default, we grant a grace period of 3 days (that is, 72 hours) for all essay submissions. You do not need to say anything if your essay is handed in 3 days or less after the official deadline. If it is submitted later, however, you will be assessed a penalty of 2% per day, and we will not accept your essay if it is more than 2 weeks late unless you have a major academic consideration from your counsellor. If you only have an academic consideration for 3 days or less, we will not grant an extension since this is already granted as part of the grace period.

ACADEMIC CONSIDERATION

Students may request academic consideration in cases of extenuating circumstances – that is, personal circumstances beyond the student's control that have a substantial but temporary impact on the student's ability to meet essential academic requirements.

1. Requests for academic consideration are made to the Academic Advising office of Faculty in which the student is registered.

- 2. Requests for academic consideration include the following components:
 - a. Self-attestation signed by the student;
 - b. Indication of the course(s) and assessment(s) relevant to the request;
 - c. Supporting documentation as relevant

Requests without supporting documentation are limited to one per term per course.

Documentation for medical illness, when required, includes the completion of a <u>Western Student</u> <u>Medical Certificate (SMC)</u> or, where that is not possible, equivalent documentation, by a health care practitioner. Requests linked to examinations scheduled by the Office of the Registrar during official examination periods as well as practice laboratory and performance tests typically scheduled in the last week of term always require formal supporting documentation.
