

## **Cannabis Physical Security Matrix**

Researchers will need to determine the security level required of their research based on the maximum amount of cannabis in possession at a given time. Researchers are required to work with the Manager, Quality & Research Compliance and Western Special Constable Service to ensure their lab's physical security meets these requirements.

Specific physical security requirements may be modified if equivalent risk reduction methods are in place that provide for an equivalent level of security. Security measures with an "X" are mandatory for a given security level.

## Appendix 1

Equivalent amount (as per Schedule 3 of the Cannabis Act). Recreated from the Cannabis Licensing Application Guide – Research September, 6, 2019

Class of cannabis	Quantity that is equivalent to 1 g of dried cannabis
Dried cannabis	1 g
Fresh cannabis	5 g
Solids containing cannabis	15 g
Non-solids containing cannabis	70 g
Cannabis solid concentrates	0.25 g
Cannabis non-solid concentrates	0.25 g
Cannabis plant seeds	1 seed

Note: Non-dried cannabis in solid and non-solid forms are considered cannabis concentrates when above 3% THC by weight.
