Projects do not need to cross agencies.

To meet the minimum requirement to be considered interdisciplinary, a proposed research project must combine elements from at least two different disciplines (as defined by a group-level classification based on <a href="https://www.statcan.gc.ca/en/subjects/standard/crdc/2020v1/index">https://www.statcan.gc.ca/en/subjects/standard/crdc/2020v1/index</a>. Projects that integrate two disciplines with a long and established tradition of working together (e.g., biology and chemistry or psychology and education) may satisfy the above requirement but not meet the expectations of the program. The onus is on the applicant to explain the novelty of the interdisciplinary approach to justify the fit to program. Interdisciplinarity is evaluated by the multidisciplinary review panel.

'QUESTION14:14: Megan Brickley: Can collaborators invoice the PI for technical costs relating to tasks undertaken as part of the project?

Answer: Collaborators do not have access to grant funds.
