Course Description: In this course, we study mathematic models for insurance loss frequency, severity,

and aggregate losses. We also study the effects of policy modifications in detail.

5. Methods of Evaluation

Assignments

Some practice questions will be assigned in class to help students understand the material. These questions are important in the preparation for the midterms and the final exam.

Midterms or Tests

Three midterm tests will be given on **Jan 31**, **Feb 28**, and **Mar 21**, respectively, during regular class time. Each midterm is 50 minutes long. The materials covered in the midterm tests are all cumulative.

Final Exam

There will be a 3-hour final exam. Its date and time will be announced by the registrar's office, usually near the first part of March. Students are required to wait until the final exam schedule is posted before planning for travel. Exams will NOT be moved to accommodate students who ignore this requirement.

Both the midterm and the final exams are closed books. The overall course grade will be calculated as listed below:

Midterm Exam 1	15%
Midterm Exam 2	15%
Midterm Exam 3	15%
Final Exam	55%

SOA-approved non-programmable calculators are allowed for the midterm tests and the final exam.

Note that this course is cross-listed with its undergraduate version AS3424. Exam questions for AS9424 may differ by up to 10% from those for AS3424.

General information about missed coursework

You must provide valid documentation for medical-related absences or adequate supporting documentation for non-medical absences to the instructor as soon as possible and no later than 48 hours after the missed assessment.

If you miss the Final Exam and your Academic Consideration has been granted, you will be allowed to write the Special Examination (the name given by the University to a makeup Final Exam).
