Course Description: Single life annuity and life insurance loss random variables and their distributions, with applications to the analysis of benefit premiums and policy values (reserves); introduction to multiple state models; survival model and their estimation.

Tests: There will be three 50-minute tests on **Wednesdays October 9, October 30 and November 13, held in-class.**

Final Exam: A 3-hour final exam will be scheduled by the Registrar's Office in the final examination period.

Note: All the above evaluations are **closed-book**.

Note: Students only have one week to request remarking their quizzes or tests after the papers are distributed back.

Assignment: There will be one assignment for this course. Students could work individually or in a group (of maximum two members) to complete the Assignment using Excel (or other mathematical software). The assignment will be posted on OWL with instructions and due date.

Take-home Quiz: It will be a take-home quiz posted on OWL, on **Monday September 23**. Students will grade it on your own and return the scorecard to **the instructor** by **Wednesday October 2**.

Specific conditions that are required to pass the course:

- a minimum **30%** of the evaluations must be completed before the final exam.

Calculators: Any non-programmable calculator may be used in this course.

Practice questions: Suggested practice questions will be posted on OWL. Assistance with solving them may also be obtained during the instructor's and TA's office hours.

AS 9429: Graduate students have one additional project weighted 5%. Accordingly, the weight of Final exam is modified to 40%.

University Accreditation Program – Canadian Institute of Actuaries (CIA)

Honours Specialization in Actuarial Science

If you graduate from Western with an HSP in Actuarial Science, this course will be one of the courses that you will take in your program that will allow you to be exempt from the preliminary exams of the Society of Actuaries (SOA). If your plan is to become a fully qualified actuary working in Canada, then all you would need to do is graduate from your HSP in actuarial science and you would then be eligible for the CIA Capstone Exam. Taking and passing this exam, along with completing two online modules and a practice education course, would make you eligible to become an ACIA (Associate of the Canadian Institute of Actuaries).

Major in Actuarial Science

If you graduate from Western with a major in Actuarial Science, the CIA accreditation program will not apply to you. If your plan is to become a fully qualified actuary, then you will need to continue to write and pass the preliminary exams of the SOA.

All Academic Consideration requests must include supporting documentation; however, recognizing that formal documentation may not be available in some extenuating circumstances, the policy allows students to make one Academic Consideration request **without supporting documentation** in this

course. However, the following assessments are excluded from this, and therefore always require formal supporting documentation:

- Examinations scheduled during official examination periods (Defined by policy)

When a student *mistakenly* submits their one allowed Academic Consideration request **without supporting documentation** for the assessments listed above or those in the **Coursework with Assessment Flexibility** section below, the request cannot be recalled and reapplied. This privilege is forfeited.

Keep in mind that it is NOT a requirement for students to use any SRA's. It is advisable for students to write the exams on the date and time they are scheduled unless you really are sick and unable to write.

With this in mind, here is information about what to do if you miss any of the required work in this course:

Take-home quiz

- Students may use an SRA
- OR they can provide documentation to academic counselling
- Those using an SRA, or with counseling approval, are still required to submit the quiz. However, the deadline is deferred for 5 days (from Oct 2 to Oct 7).

Assignment

- Students may use an SRA (as long as it has not already been used before)
- OR they can provide documentation to academic counselling
- Those using an SRA, or with counseling approval, are still required to submit the assignment. However, the deadline is deferred for 5 days.

Midterm 1

- Students may use an SRA (as long as it has not already been used before)
- OR they can provide documentation to academic counselling
- For those using an SRA, or with counseling approval, the weight of the midterm (15%) will be reassigned to the final exam.

Midterm 2

- Students may use an SRA (as long as it has not already been used before)
- OR they can provide documentation to academic counselling
- For those using an SRA, or with counseling approval, the weight of the midterm (15%) will be reassigned to the final exam.

Midterm 3

- Students may NOT use an SRA
- Students must provide documentation to academic counselling
- For those with counseling approval, the weight of the midterm (15%) will be reassigned to the final exam.

Project for Graduate student

- Students may NOT use an SRA
- Students must provide documentation to academic counselling
- For those with counseling approval, the weight of the project (5%) will be reassigned to the final exam.

Evaluation Scheme for Missed Assessments

Missed Quiz or Test: There will be **no make-up exams** for a missed quiz/test. For those that do legitimately miss a quiz/test and their Academic Consideration has been granted, the standard practice will be that the weight of the quiz/test will be reassigned to the final exam. If the Academic Consideration is not granted, then you will receive a mark of 0.

When a student misses the Final Exam and their Academic Consideration has been granted, they will be allowed to write the Special Examination (the name given by the University to a makeup Final Exam). See the Academic Calendar for details (under [Special Examinations](#)), especially for those who miss multiple final exams within one examination period.

Essential Learning Requirements

Even when Academic Considerations are granted for missed coursework, the following are deemed essential to earn a passing grade.
