3. Course Syllabus, Schedule, Delivery Mode



Course Description

Completely randomized designs, randomized complete and incomplete block designs, factorial and fractional factorial designs, latin square designs, hierarchical designs, random and fixed effect model. Additional material may be added as time permits.

Course Objectives



To make use of appropriate designs when analyzing various types of experimental data, and then, to be able to test relevant hypotheses and interpret the results.

Contingency plan

5. Methods of Evaluation

The overall course grade will be calculated as follows:

Presentation

Students will be required to give an oral presentation - worth 25% of the course mark

No assignments but problems will be suggested and solutions, provided.

Tests

Two *in-class* tests, each worth 25%, the first one to take place on Wednesday October 9th and the second one, on November 13th. In the event that one misses a test and provides the required supporting documentation, the other test will be worth 35%, the oral presentation 35% and the final project 30%. If one misses the first test, the presentation must take place by October 23rd. As per departmental policy, no make-up exam will be administered. The tests are 'closed book' although crib sheets may be allowed as will be specified beforehand on OWL. A nonprogrammable calculator will be required.

Final Project

No final exam but a final project worth 25%.

A self-reported absence may only be submitted for one of the tests.

Academic Policies
