BEDARD, Denise***PhD / Health and Rehabilitation Sciences***

I am a PhD candidate in Health and Rehabilitation Sciences with extensive experience spanning senior leadership, community-based care, and Long-Term care homes. In addition to my doctoral studies, I served as CEO of a not-for-profit long-term care organization, where I worked closely with boards, regulators, and multidisciplinary teams to advance quality, equity, and accountability for residents. This leadership background has shaped my strong interest in governance, policy, and inclusive decision-making. My interest in seeking election to the Senate stems from a commitment to ensuring that graduate student voices, particularly those balancing research, leadership, caregiving, and community engagement, are meaningfully represented in institutional decision-making. I would bring to the Senate a collaborative lens informed by governance experience, applied research, and community partnership. I am particularly interested in contributing to discussions related to graduate education, student well-being, equity, and the translation of research into societal impact. I value thoughtful dialogue, transparency, and evidence-informed decision-making, and I would be honored to serve the graduate student constituency in this role.

KAMAL, Rayyan***PhD / Anatomy and Cell Biology***

I am Rayyan Syed Kamal, a PhD candidate in Anatomy & Cell Biology at Western's Schulich School of Medicine & Dentistry. I'm seeking election as a graduate student Senator because Senate decisions on academic policy, program quality, and standards shape the day-to-day realities of graduate training across Western. Over the past 10 years at Western, I've been deeply involved in student communities and leadership roles, keeping me closely connected to what students need to succeed. I will consult graduate students before key decisions, elevate concerns around funding stability, teaching opportunities, and well-being, and communicate outcomes back in clear, practical language, while collaborating respectfully across disciplines to advance academic excellence for the whole University.

I am an active campus member serving as Vice President of External Communications for the Health and Rehabilitation Graduate Student Society and Senior Advisor for the Health Studies Students' Association. These experiences have strengthened my ability to work collaboratively and represent diverse perspectives.
