As a Health Sciences-Ivey dual-degree student, I'm running to serve as Ivey's Undergraduate Senator. Ivey's culture is loud, but isn't the full story. I've heard quieter conversations: difficulty finding your people even within your section, subtle discrimination, and the pressure of keeping up in an environment that moves fast but doesn't always listen. As President of Western's Health Sciences Program, former President of Western Founders Network, a Section 2 OWL (Pylons unite!), and a former Residence Soph, I've worked closely to listen to students at different stages of their journeys and translate frustration into dialogue decision-makers pay attention to. This year, I created a motion to address ancillary fees owed to my council, advocated for student donations to be prioritized toward student opportunities over capital expenses, and advanced conversations with faculty surrounding neurodivergence and universal design. Working closely with Ivey's current Senator, I've seen how underutilized Senate representation is and how much potential exists to better connect Ivey students to university-wide policy. I'm running because I care deeply about closing that gap. I bring a deep understanding of Ivey within the broader university, experience navigating the bureaucracy, and a commitment to ensuring student concerns don't stop in the hallway.
